

RESOLUTION AUTHORIZING A CONTRACT WITH S. BROTHERS, INC.

WHEREAS, the Township of Livingston ("Township") has the need for the Ross Road culvert replacement and milling and paving of Ross Road that cannot otherwise be performed by its regular employees; and

WHEREAS, on July 13, 2017, the Township of Livingston issued Bid No. 21-2017 to solicit bids from contractors experienced in culvert replacements and milling and paving; and

WHEREAS, the bid was advertised on the Township of Livingston website and West Essex Tribune on July 13, 2017 and as a result twenty-seven (27) bid packages were requested; and

WHEREAS, on August 9, 2017, five (5) bids were received by the bid deadline and publicly read; and


WHEREAS, S. Brothers, Inc. was identified as the lowest responsive and responsible bidder whose bid meets all of the requirements of the bid specifications, complies with the requirements of N.J.S.A. 10:5-31 et seq. and N.J.S.A. 17:27 et seq.; and

WHEREAS, the Township Engineer has evaluated the proposal for qualifications, experience, and cost reasonableness, and recommends the award of a contract to S. Brothers, Inc.; and

WHEREAS, the Deputy Township Manager is recommending the award of a contract to S. Brothers, Inc. in an amount not to exceed \$910,314.10; and


WHEREAS, the Chief Financial Officer has certified that funds are available in account C-04-55-017-004-002.


