

**RESOLUTION AUTHORIZING A CONTRACT WITH BRUNSWICK BUILDERS, LLC**

**WHEREAS**, the Township of Livingston (“Township”) has the need for the animal shelter facility expansion that cannot otherwise be performed by its regular employees; and

**WHEREAS**, on July 20, 2017, the Township of Livingston issued Bid No. 22-2017 to solicit bids from contractors experienced in facility expansions; and

**WHEREAS**, the bid was advertised on the Township of Livingston website and West Essex Tribune on July 20, 2017 and as a result twenty-seven (27) bid packages were requested; and

**WHEREAS**, on August 16, 2017, four (4) bids were received by the bid deadline and publicly read; and

**WHEREAS**, Brunswick Builders, LLC was identified as the lowest responsive and responsible bidder whose bid meets all of the requirements of the bid specifications, complies with the requirements of N.J.S.A. 10:5-31 et seq. and N.J.S.A. 17:27 et seq.; and


**WHEREAS**, the Chief of Police has evaluated the proposal for qualifications, experience, and cost reasonableness, and recommends the award of a contract to Brunswick Builders, LLC; and

**WHEREAS**, the Acting Township Manager is recommending the award of a contract to Brunswick Builders, LLC in an amount not to exceed \$87,553.00; and


**WHEREAS**, the Chief Financial Officer has certified that funds are available in account C-04-55-011-014-008 and 7-01-26-310-001-203.
